

We, Elegant Boutiques, are committed to protecting any data that we collect concerning you. By using our services, you agree to the use of the data that we collect in accordance with this Privacy Policy.

The purpose of this Privacy Policy is to enable you to understand what personal information of yours is collected, how and when we might use or share your information, and how you can correct any inaccuracies in the information. This Privacy Policy also explains our online information practices and the choices you can make about the way your information is collected and used.

This privacy policy has been compiled to better serve those who are concerned with how their personally identifiable information is being used online. Please read our privacy policy carefully to get a clear understanding of how we collect, use, protect or otherwise handle your Personally Identifiable Information in accordance with our website.

1. GENERAL

The operative parties referred to in this policy are Company and You, the User of this site.

Elegant Boutiques is the publisher and operator of the website(s) listed at the beginning of this Policy. Hereinafter, Elegant Boutiques shall be referred to as "Company". When first-person pronouns are used in this Policy, (Us, We, Our, Ours, etc.) these provisions are referring to Company. Additionally, when the terms "the Site" or "Site" are used, these terms refer to the website(s) listed at the beginning of this Policy.

You, the User - As the User of this Site, this Policy will refer to the User as "You" or through any applicable second-person pronouns, such as "Yours," etc. Hereinafter, the User of the Site shall be referred to in applicable second-person pronouns.

This Privacy Policy describes how we use information received about You when You visit Our Site or when You subscribe to, or otherwise use Our online services. This Policy does not cover any information that We may receive from or about You through channels other than through the use of the Site.

2. What personal information does Elegant Boutiques collect from the people that visit Elegant Boutiques.com?

When requesting or purchasing services or registering on our site, as appropriate, you may be asked to enter your name, email address or other details to help you with your experience.

Visitors to Our Site and services will have multiple manners of interactivity with Us. Depending upon Your level of interaction, We will collect different information about You. The type of information collected is as follows:

Patrons - Patrons are those Users who interact with Our services in a way which requires registration, such as by uploading content to the Site. Patrons will be prompted to provide a valid e-mail address in the process of registering a username.

Browsers - Browsers are visitors to the Site who never enter into any active data collection pages. Browsers may, however, view content uploaded by Patrons. Any information gathered from Browsers is also gathered from Patrons. This information is restricted to cookies, IP Addresses and Referral URLs, and other passive information gathering devices (explained below).

Customer Surveys. We may periodically conduct customer surveys. Participation in our customer surveys is voluntary. However, we encourage our users to participate in these surveys because they provide us with important information that helps us improve the types of services we offer and how we provide them to you.

Your personal information, if provided, will remain confidential, even if the survey is conducted by a third party service provider on our behalf.

Social Media. Our website includes social media features (such as the Facebook "Like" button). These features may collect your IP address and which page you are visiting on our website, and may set a cookie to enable the feature to function properly.

Social media features and widgets may be hosted by a third party or directly on our website. Your interactions with these features are governed by the privacy policy of the company providing the feature.

3. When does Elegant Boutiques collect information?

Elegant Boutiques collects information from you when you request services, purchase services, subscribe to a newsletter or enter information on our site. This information collection process can be categorized into:

Passive Collection - We use cookies to collect information about You in order to enhance Your experience on the Site. The information collected in Our cookies includes, but is not limited to, Your User IP address, geographic location and other session data.

Active Collection - We collect information from You, such as Your name, e-mail address and credit card information, if applicable, when You complete registration forms to sign up for Your services on Our Site. Locations for such collection are registration or personal profile pages, but We reserve the right to add additional information collection portals.

4. How does Elegant Boutiques use your information?

Elegant Boutiques may use the information we collect from you when you register, request services, sign up for our newsletter, respond to a survey or marketing communication, surf the website, or use certain other site features in the following ways:

- * To quickly process your transactions.
- * To send periodic emails regarding your order or other products and services.

However, the primary use for Your information is to provide You with services You have requested and/or paid for. We also use Your information to deliver customized

services to You. Patron login information and e-mail addresses may be disclosed to third parties for the purpose of providing certain features or third-party upgrades as requested by the Patron.

We are not responsible for how third parties use your information, and You should become familiar with such third parties' privacy policies prior to requesting their services. Non-personal and aggregate information, such as that collected passively is used in order to customize Our marketing efforts or to customize the use of Our Site for an aggregate group of customers. We additionally may use the personal information of Users whose account has expired or has been cancelled in order to market Our services to these individuals in the future.

We generally will use Your information for the purposes for which You specifically provide it, for example, to ensure payment for subscription services, if applicable. We also use Your information for market research purposes – in order to increase Your (and other Users') experience according to tracked interests, to analyze and target potential new markets, and for other marketing purposes.

We also use Your information for the obvious purpose of providing Your User profile to all of Our other Patrons and Browsers. When You create a profile, You should consider all of the information on the profile to be public information, accessible by anyone, unless otherwise stated. Even if You choose to not make public Your personally identifying information, You should understand that there is a possibility that You may be identified through information You provide on Your profile. For example, You may be visually recognized by someone who sees Your picture or Your description may be adequately detailed that someone browsing the Site would be able to tell that the person is You. Accordingly, You understand that using this Site places You in control of all of the information displayed on Your profile, and You are fully responsible for any consequences arising out of such information You choose to publish.

5. How does Elegant Boutiques protect visitor information?

Our website is scanned on a regular basis for security holes and known vulnerabilities in order to make your visit to our site as safe as possible.

Your personal information is contained behind secured networks and is only accessible by a limited number of persons who have special access rights to such systems, and are required to keep the information confidential. In addition, all sensitive/credit information you supply is encrypted via Secure Socket Layer (SSL) technology.

Elegant Boutiques implements a variety of security measures when a user places an order enters, submits, or accesses their information to maintain the safety of your personal information.

All transactions are processed through a gateway provider and are not stored or processed on our servers.

6. Cookies

Elegant Boutiques, LLC. uses cookies on Elegant Boutiques.com and related domains

and applications (the “Elegant Boutiques, LLC. service”). By using the Elegant Boutiques, LLC. service, you consent to the use of cookies.

6.1. Do we use ‘cookies’?

Yes. Cookies are small files that a site or its service provider transfers to your computer’s hard drive through your Web browser (if you allow) that enables the site’s or service provider’s systems to recognize your browser and capture and remember certain information. For instance, we use cookies to help us remember and process the items in your shopping cart. They are also used to help us understand your preferences based on previous or current site activity, which enables us to provide you with improved services. We also use cookies to help us compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future.

We use cookies to:

- * Help remember and process the items in the shopping cart.
- * Understand and save user’s preferences for future visits.
- * Compile aggregate data about site traffic and site interactions in order to offer better site experiences and tools in the future. We may also use trusted third party services that track this information on our behalf.

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser (like Internet Explorer) settings. Each browser is a little different, so look at your browser’s Help menu to learn the correct way to modify your cookies. If you disable cookies off, some features will be disabled it won’t affect the users’ experience that make your site experience more efficient and some of our services will not function properly. However, you can still place orders.

6.2. What is a cookie?

A cookie is small text file that is stored in your web browser after your visit a website. Cookies assist the website in remembering information about your visit, such as your unique browser session and settings. Cookies can help provide you with a better experience when you use the Elegant Boutiques, LLC. services.

Cookies can either be session cookies or persistent cookies. Session cookies are temporary cookies, and they are erased after you close your browser. When you restart your browser and return to the Elegant Boutiques, LLC. service, the website will not recognize you and you will have to log back in (if login is required) or select your unique preferences/settings again. Persistent cookies remain in your browser’s subfolders until they expire or you delete your cookies. Expiration dates are set within the cookies themselves, and some may expire after a few minutes while others may expire after many years.

The Elegant Boutiques, LLC. service uses both “first party cookies,” which are cookies placed by the Elegant Boutiques, LLC. service, and “third party cookies,” which are cookies placed by other select other companies.

Please note that other technology, such as Adobe Flash or Javascript, can place the functional equivalent of a cookie on your computer.

6.3. What cookies are used when I use the Elegant Boutiques, LLC. service?

Cookies may be set by the Elegant Boutiques, LLC. service when you visit Elegant Boutiques, LLC. 's websites, or they may be set by a third party that runs content on the page you are viewing. Some cookies will only be used when you use certain features on the Elegant Boutiques, LLC. service, and some cookies will always be used. We reserve the right to amend and modify this list, so there may be additional cookies that are not currently listed.

Each cookie the Elegant Boutiques, LLC. service uses serves a variety of purposes, including:

Authentication: the Elegant Boutiques, LLC. service uses cookies to recognize you if you are logged into the Elegant Boutiques, LLC. service, so that we can personalize your experience.

Security: the Elegant Boutiques, LLC. service uses cookies to support or enable security features we use to detect any malicious activity or violations of our User Agreement.

Preferences: these first party cookies store your Elegant Boutiques, LLC. service preferences, such as your language, country, IP address, and communications preferences (this listing may not be all inclusive and is subject to change). Additionally, they provide you with customized content and features through our plugins.

Analytics: the Elegant Boutiques, LLC. service uses these cookies to track information about how we make improvements to the Elegant Boutiques, LLC. service and report our performance. We use these cookies to track our sites and plugins performances across the globe. Similarly, we may also use these analytics cookies to test new ads, pages, or features to gauge users' reactions. 6.6. Does the Elegant Boutiques, LLC. service use any other data about me?

7. Third Party Disclosure

Elegant Boutiques does not sell, trade, or otherwise transfer to outside parties your personally identifiable information unless we provide you with advance notice. This does not include website hosting partners and other parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release falls under one of the special cases as described in the next section.

8. Special Cases.

It is Elegant Boutiques policy not to use or share the personal information about Browsers or Patrons in ways unrelated to those described in this Policy without also providing You an opportunity to opt out or otherwise prohibit such unrelated uses. However, Elegant Boutiques may disclose personal information about Browsers or Patrons, or information regarding Your use of the services or Site(s) accessible through Our services, for any reason if, in Our sole discretion, We believe that it is reasonable to do so, including:

- * To satisfy any laws, such as the Electronic Communications Privacy Act, regulations, or governmental, or legal requests for such information;
- * To disclose information that is necessary to identify, contact, or bring legal action against someone who may be violating our Terms & Conditions or other User policies;
- * To operate Our services properly;
- * To protect ourselves, Our Patrons, and the general public. We specifically reserve the right to disclose any and all information to law enforcement in the event that a crime is committed, is suspected, or if We are compelled to do so by lawful criminal, civil, or administrative process, discovery requests, subpoenas, court orders, writs, or reasonable request of authorities or persons with the reasonable power to obtain such process.
- * If We have reason to believe that the User is not the owner of a credit card, even if the credit card use is authorized, We will provide information about You to the credit card holder. We will absolutely provide Your information to the credit card

holder if We believe that fraud is a possibility. However, We do not require that there be fraud, as it is Our policy that the credit card holder always has an absolute right to access any and all of Your personal information.

* Anyone who violates Our Anti-Spam Policy, if applicable, shall have their personal information made public. If there is any investigation on any unlawful spamming, or any use of bulk e-mail in order to promote Your User profile, or any use of bulk e-mail in any manner that leads back to Our Site, or any one of Our Sites, We will cooperate with any and all parties completely and freely in order to see that Your bulk e-mail activities stop.

However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.

9. Third Party Links

Elegant Boutiques does not include or offer third party products or services on our website.

What Elegant Boutiques consider a "third party site"

We define a "third party site" as a website that we are not directly affiliated with and where we do not control any of the content. How you'll be informed that you're about to visit a "third party site"

When possible, a Javascript alert will pop up notifying you that you're leaving our site. When the javascript alert is not possible, there will be a "third party link" notice on the page. Visitor's responsibilities

- * Is the person living in unsuitable conditions?
- * Does the person lack personal possessions and appear not to have a stable living situation?
- * Does the person have freedom of movement? Can the person freely leave where they live? Are there unreasonable security measures?

Not all indicators listed above are present in every human trafficking situation, and the presence or absence of any of the indicators is not necessarily proof of human trafficking.
